The work will we be doing

BBV will be carrying out installation works of monitoring equipment to the existing Network Rail assets. This is to allow for monitoring of the assets before and during construction works for HS2. Monitoring equipment will be installed to the existing rail, overhead gantries and to the two bridges between Berkswell Station and Truggist Hill Farm. Please see below map for works location.

When these works will take place

Works are scheduled for Sunday 21 February and Sunday 28 February. These works are subject to weather conditions.

The West Coast Main Line will be closed between 0.00am and 8.30am on both days. The workforce will meet and access the rail through the rear of Berkswell Station car park. We will keep you updated through www.hs2insolihull.co.uk.

- Low levels of noise from the work we are completing.


