

Notice of Ground Investigation Work –Thorpe Mandeville to Boddington

High Speed Two (HS2) is the new high speed railway for Britain.

Who are Eiffage Kier?

Eiffage Kier is the contractor carrying out the civil engineering works for the new HS2 line. Eiffage Kier will undertake all earthworks and landscaping as well as creating new structures including bridges, viaducts and green tunnels.

What are we doing?

As part of HS2's preparation works, we will be carrying out ground investigations along the route to provide technical information about the ground conditions. They are part of the early works that Eiffage Kier will carry out this year, in advance of the main works.

When will these works take place?

Although some ground investigation works have been carried out, further investigations are necessary as the detail of the design is now more mature. They will take place from November 2019 to mid 2020.

What does the work involve?

The works involves setting up a work compound, carrying out ground investigations along the line of the new railway and in one location forming five piles known as a 'test pile'.

A works compound will be set up to provide the base from which the ground investigation will be carried out. The compound is being set up in November at the existing site entrance to the heave cutting works on Stoneton lane near Wormleighton.

Duration of works

Normal working hours: Monday to Friday 8.00am - 6.00pm Saturdays 8.00am - 1.00pm

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Varied activities with both quiet and busier periods.

Agreed routes will be used by a small number of HGVs and vehicles. A lot of equipment will be moved by local farm tractors and trailers.

What we will do

Manage any environmental impacts, such as traffic and noise.

Inform you of any changes to the provided dates. Respond promptly to any complaints and take appropriate action The ground investigation works include using ground radar and bore holes and we will be using a mixture of these techniques to take rock and soil samples. A typical bore hole has a diameter of 200mm and can vary in depth from between around 10 metres and 50 metres. Small pits known as trial pits will also be excavated. These tend to be about 4 metres long, less than a metre wide and up to 4 metres deep. The photograph below shows a borehole operation.



Concrete 'Test Piles' will also be formed in one location near to the works compound. These are concrete foundations formed by excavating a small diameter deep holes and filling it with concrete. Five piles will be formed that are 1.5 metres in diameter and around 40 metres deep.

How will this affect me?

The works will be carried out by teams of three or four and all investigation locations will be safely reinstated. Works at any one location will generally not exceed two weeks. We do not expect any impact on highways however neighbours near to work sites may hear drilling.


Sequence of Works
