



Notice of Little Missenden vent shaft works

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with Covid19. The Government's current strategy makes it clear that construction sites can operate as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under current review.

What is happening on site?

We are starting enabling works to set up the site before we begin construction of the ventilation shaft at Little Missenden in late Spring next year. You will start to see vehicles, including a small number of heavy goods vehicles (HGVs), accessing the site to build hard standing for vehicles and the construction of offices, welfare facilities, site security, drainage systems and the platform for the drilling rig. This will involve soil movement and creation of stock piles around the site. Security lighting and fencing will also be erected around the site boundary. Public Right of Way LM1/40/2 is being diverted around the site boundary and this will be signposted. This is a temporary diversion until the main works are completed.

We will also be conducting a number of surveys both within the site and along the A413. Some of the surveys will require additional traffic management whist they are taking place. The information gathered will help us with the final design for the vent shaft and access to the site for the main works next year. We will update you on what this will look like in a future notice. The traffic management will remain on the A413 to allow safe access for vehicles to and from the site. This will be removed once the permanent access has been built.

Installation of track matting, lighting and some soil excavation and stockpiles on site. Fencing erected around the site boundary

Closure and diversion of Public Right of Way on 2 November
