Update of sewer construction works on **Harrington Street**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review. Update on works for Harrington Street

We wrote to you last year to let you know about sewer construction works that started on 12 October 2020, as works progress through phase 5 we have decided to combine phases 6 & 7 to minimise disruption to the area and reduce the construction time on site.

Overview of sewer construction works

Sewer construction works started on 12 October 2020 on Harrington Street. The works will continue in phases until end summer 2021 to maintain access to the street buildings.

We have completed first 4 and phases and constructed a 3m diameter manhole at the junction with Varndell Street and working northwards laying down the sewer pipeline along the west side of the road. The pipeline will be connected to the 2.4m and 2.1m diameter manholes, which yet to be constructed at the junction with Mackworth Street.

To carry out excavation works safely we will need to close the west side footpath in each location of works. The east side of the road will be used as a safe running lane for the machinery and emergency services, refuse collection will be maintained at all times.

The initial digging/breaking out of the road surface will be the noisiest activity, although this will be intermittent. We will erect acoustic panels to reduce noise. Utility supplies and other services will not be affected by these works.

Duration of works

From 12 October 2020 until end September 2021 in phases

Working hours:

Monday to Friday 8am -6pm,

Saturday 8am – 1pm

We may be onsite for one hour either side of the hours above for start-up and shutdown

Traffic management around work sites and in surrounding roads

Parking bay suspensions

Pedestrian access will be maintained during the works

Access maintained for emergency services

Phase 6 & 7. Works in front of the Harrington House access road / Junction with Mackworth Street

From mid-June to end September works will be carried out in front of the Harrington House access road and road will be closed up to Mackworth Street. We will continue excavation works and laying the pipeline.

Vehicular access to Harrington House including emergency services and refuse collection will be via Varndell Street - Harrington Street South and maintained via tuff track covered footpath.

Pedestrian access to Harrington House will be only via Stanhope Street.

During phase 7, we will construct 2.4m and 2.1m diameter manholes and finalise pipework connection at junction of Mackworth Street. The road will be closed during this phase.

We will maintain London Fire Brigade access to Langdale in case of emergency via southbound lane. Footpath will remain open on the east side and northern side of the road.


