

Update: Vegetation clearance at Canterbury Works site

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

Removal of vegetation from 5 March 2021

As part of our ongoing works, we will be clearing vegetation within our Canterbury Works site. The vegetation removal works are planned from 5 March for approximately one week. We will be working Monday to Friday 8am to 6pm and Saturday 8am to 1pm if required.

These works will take place along our site boundary with St Mary's Catholic Primary School (CPS). A map showing the location of the works is included on the next page. To ensure safety during these works a small exclusion zone may be required within the school grounds. We are speaking with St Mary's CPS about this.

We will continue to monitor our working methods to ensure that any disruption is kept to a minimum. The dates and times may change due to unforeseen circumstances. We will keep you informed at HS2inKilburn-Northolt.co.uk.
