# Notice of water connection works at Mandeville Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

## Installation of water mains connection

From Friday 19 February 2021, we will be carrying out water connection works in the area shown on the map overleaf. This will help us to install the water supply that will be used throughout our works site.

Affinity Water will install the water supply at the entrance of Mandeville Road Vent Shaft site. These works will include the excavation of a trench to install connection pipes.

## How this may affect you

You may see people and equipment operating near the site access. The initial digging/breaking out of the road will be the noisiest activity, although this will be intermittent and not continuous.

Noise and vibration monitoring will be conducted to ensure works are within project approval limits. Water carts will be used to reduce the amount of dust generated by this activity.

These works will take place from **19 February 2021** for four weeks

Working hours are between **8am** and **6pm** Monday to Friday and **8am** to **6pm** on Saturday if required

Affinity Water workers and excavation equipment to dig the trench for the installation of water pipes

Your utility services will not be affected

### What we will do

Conduct noise and vibration monitoring to ensure works are within project approval limits

Use water carts to keep dust to a minimum

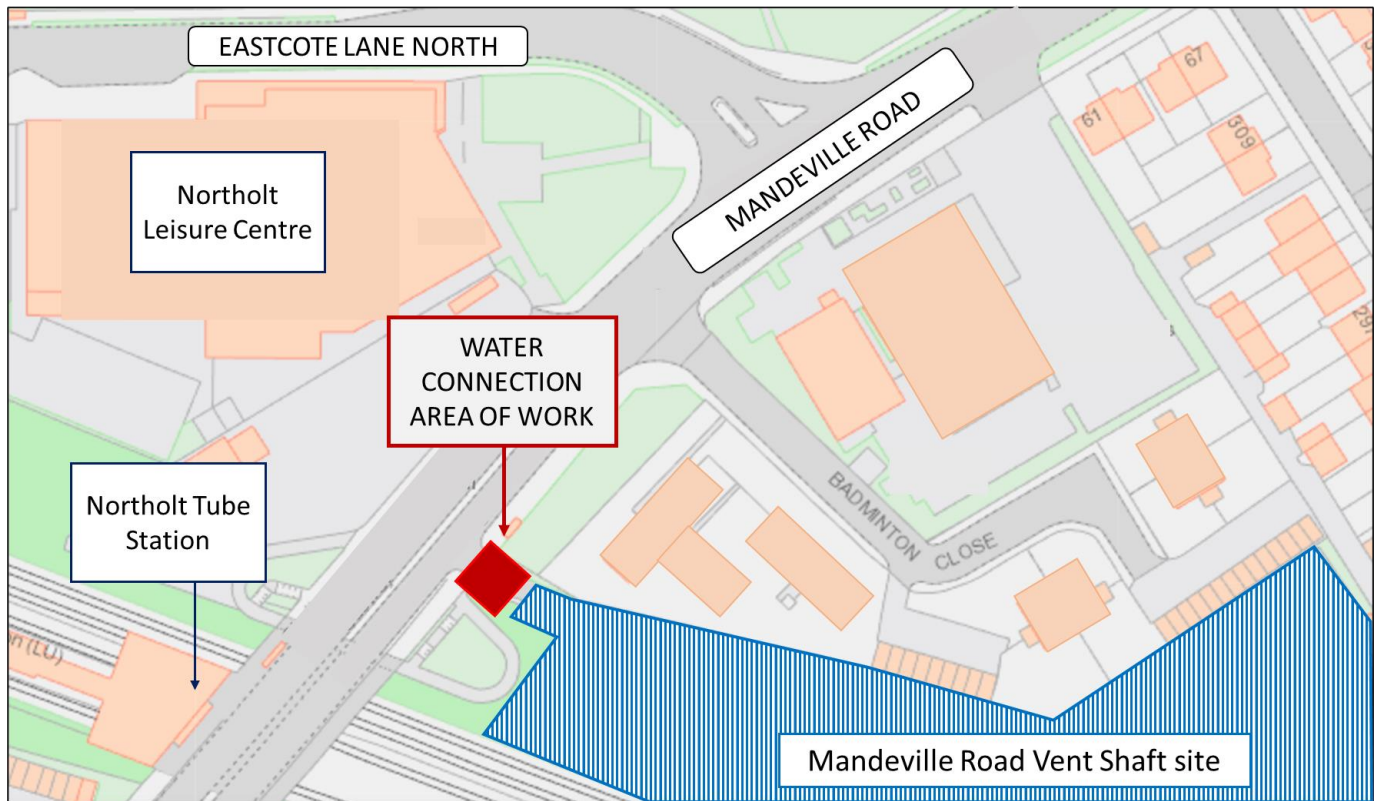
