High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

Overnight drainage survey on 15 to 19 March

We will be carrying out drainage surveys in the Flat Iron site on Victoria Road. These works will take place overnight from 15 to 19 March, between 9pm and 6am the following morning. The surveys must take place overnight as the site is operational during daytime hours.

The location of the surveys is shown in the map on the following page.

The surveys will help us to investigate the condition of the drainage system and consider the best way to protect them while we build HS2. We may need to flush the drainage using a high-pressure water jet if any blockages are found. Some noise may be heard during this process.
