High Speed Two (HS2) is the new high speed railway for Britain.

Installation of lighting on Channel Gate Road fencing

As you may be aware, SCSJV has been making changes to how we manage Channel Gate Road. The solid wooden hoarding installed at the junction of Old Oak Lane and Channel Gate Road during late 2020 has now been replaced with rigid mesh fencing.

From mid to late-March, we will install lighting on the fencing along the southern side of Channel Gate Road. Work to install the lighting will take place during core working hours of Monday to Friday 8am to 6pm and Saturday 8am to 1pm if required.

The lighting will look the same as the lighting installed along the fencing on the northern side of the road in late-2020.

Update: ongoing works in Willesden Euroterminal site

The following works are ongoing in the Willesden Euroterminal site during March:

- Works to build site roads
- Works to build storage areas for future excavated materials
- Refurbishment of the existing ('Breadbin') building
- Upgrades and maintenance to the rail infrastructure in this site

Measures are in place to minimise disruption to our neighbours.
