



Notice of temporary footpath closure - Tamworth Road, A51

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we are doing

We are working closely with Whittington Heath Golf Club to undertake the removal of their former clubhouse. A safe working area has been created at the site to allow for the building to be demolished. In order for the works to be completed in a safe environment we need to install scaffolding around the building which will require a temporary closure of the footpath outside.

We will have clear signage in place to direct members of the public to use the footpath on the other side of the road, during the temporary closure.

During these works, our vehicles will use the existing access to the former clubhouse. Members and visitors to the Golf Club will continue to use the new access, created by the Golf Club, off Common Lane (**see map below**).

When will we undertake these works

We will temporarily close the footpath between 1 March to 2 April 2021 to complete these works safely.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

Keep all sites safe and secure.

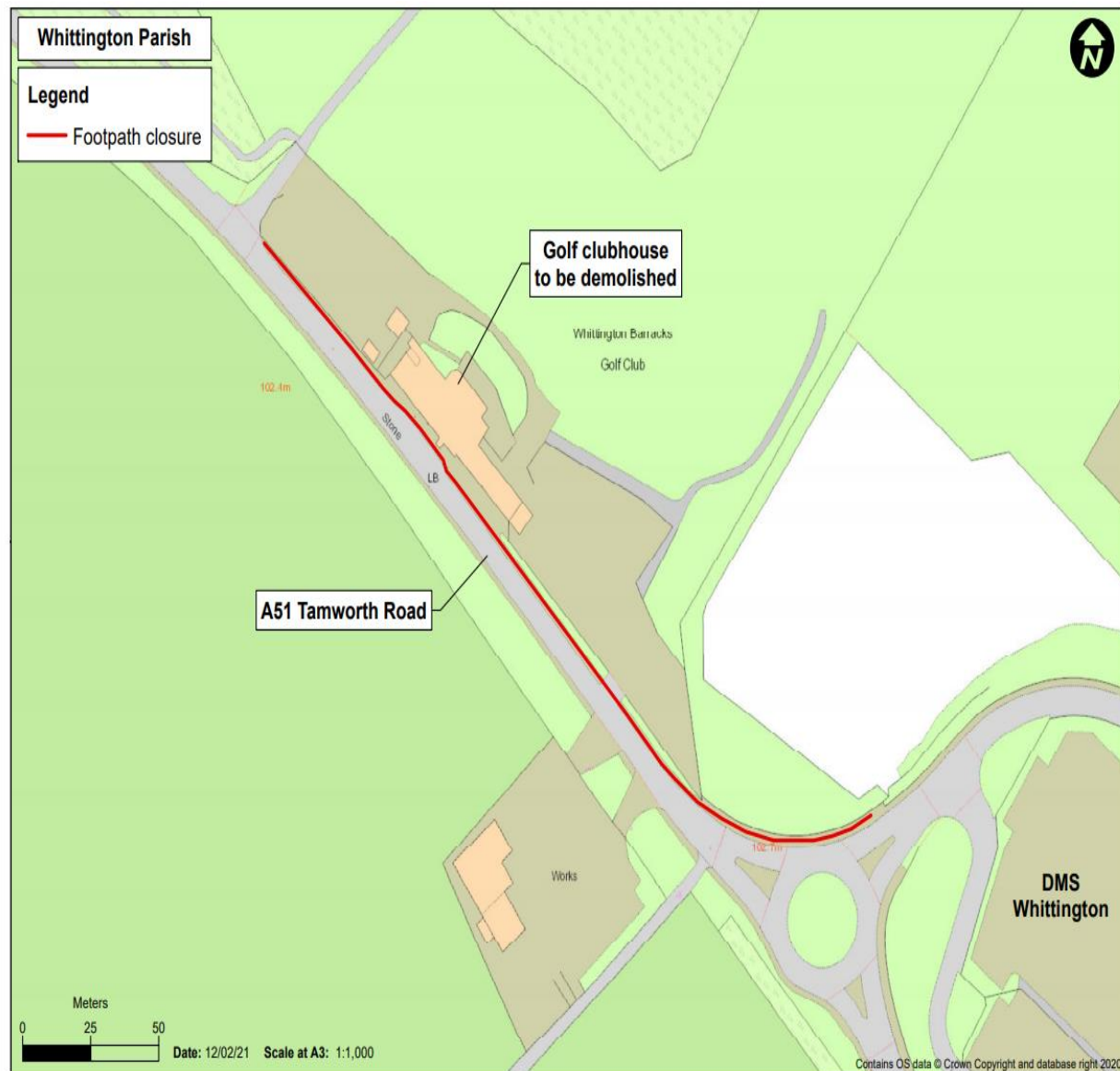
