



Notice of vegetation maintenance

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance.

Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. Why are the works taking place now?

In 2020 we carried out improvements to the junction of Ledborough Lane, the A355 and Longbottom Lane. Following a recent review of these work it has been highlighted that some localised vegetation maintenance is required to the corner of the exit from Longbottom Lane onto the A355 towards Beaconsfield.

What are we doing?

Before we can begin the vegetation maintenance at the junction the safety of our workforce and road users, we will put in place three - way temporary traffic lights on the 29 March 2021 between 9:30am and 3pm to minimise disruption to the road network. As soon as our works are completed all traffic management will be removed

The vegetation maintenance will generate low levels of noise. An ecologist will check the work area before works commence. We will continue to work hard to ensure that any impacts on residents are kept to a minimum during these works. This work is subject to consent and approval from the local authority.
