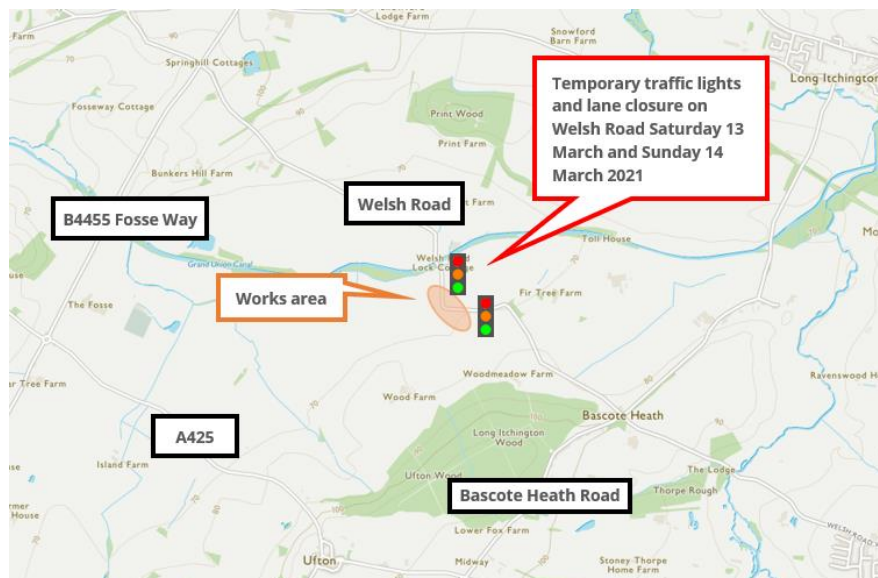
High Speed Two (HS2) is the new high speed railway for Britain. Initial works have now started and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

## Temporary traffic lights on Welsh Road

LM will be erecting temporary traffic lights with a single lane closure on Welsh Road on Saturday 13<sup>th</sup> and Sunday 14<sup>th</sup> March to ensure we create a safe working zone whilst we carry out essential remedial works to the main access point at the HS2 compound.

Access will still be maintained for households and businesses along the road. All works are subject to consent, site and weather conditions. Dates may also be subject to change.
