High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be carrying out trial trenching, along a section of Faraday Avenue, which will involve digging into the ground to establish what is underneath the surface. This will provide us with information on the location of underground utilities, which we need to assess as we develop our construction plans. For the work to be completed in a safe environment we will be installing lane closures on Faraday Avenue.

When these works will take place

We will only close one lane at a time. Between 28 June and 2 July, a single lane closure of the outbound will be required between the Hams Hall roundabout on the A446 and past the Edison Road roundabout within the Hams Hall Industrial Park.

Between 5 July and 9 July, a single lane closures of the inbound carriageway will be required between the Hams Hall roundabout on the A446 and the Edison Road roundabout within the Hams Hall Industrial Park.

These surveys will take place between 28 June and 9 July.

Our working hours will be 9.30 am to 3.30 pm (Mon-Fri).

Our workforce may be on site one hour before and after to set up and take down our work equipment.

What to expect

Lane closures will be in operation during this period.

We will install clear signage to inform road users of the lane closures.

Some low level noise will be generated from the work we are completing.

What we will do

Inform you in advance of any changes to the dates shown.

Keep all sites safe and secure.

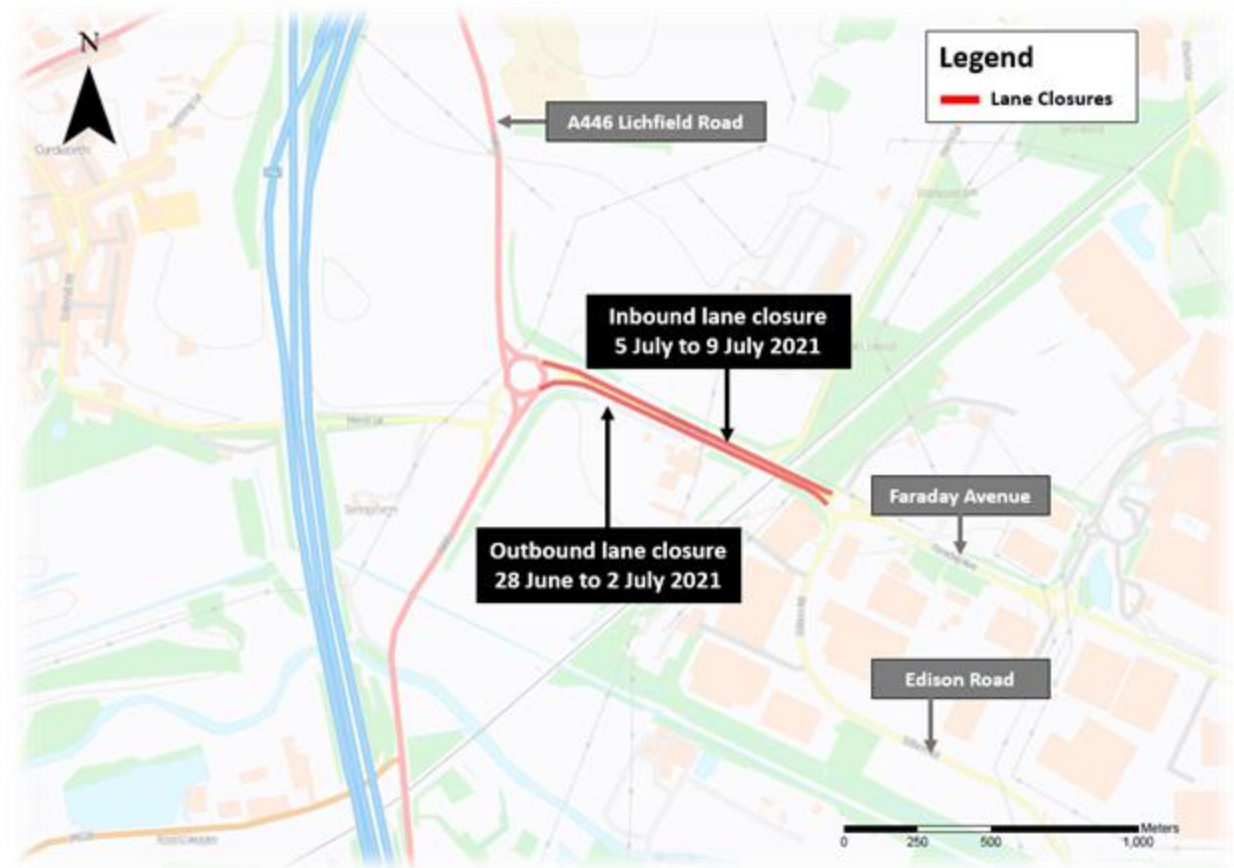
