Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

We are undertaking topographical surveys along the course of the Ickenham Stream from The Greenway, (above the Thames Water sewer) down to the junction with Ickenham High Road. This work is carried out by a small number of operatives and will take no more than a couple of days to complete. The operatives will be using a 'total' station, as shown in the picture below. We are undertaking this work now to prevent having to cut back undergrowth later in the year.
