Notice of works to prepare for construction of conveyor

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

Vegetation clearance works next to Dudding Hill bridge foundations in Flat Iron and Atlas Road sites

During 2021, we will build a conveyor system between our sites in Old Oak and Park Royal to allow for the movement of excavated material between sites. This will assist with reducing construction traffic on local roads while we build HS2.

We are preparing to install the conveyor foundations within our sites. As part of these works, we will be carrying out vegetation clearance next to the Dudding Hill Bridge foundations on Victoria Road. We need to trim six trees and remove one tree along the conveyor route in this area.

Work will be completed in two phases between 29 March to 2 April:

- Phase one Northern abutment of Dudding Hill bridge from 29 March to 30 March 2021
- Phase two Southern abutment of Dudding Hill bridge from 31 March to 2 April 2021

During these works we will be installing a safety exclusion zone with a partial footpath and lane closure on Victoria Road. Traffic management will be in place during our working hours and will be manually controlled to maintain traffic flow. Bus Stops V & N on Victoria Road will be temporarily suspended during these works. A map of the two phases and traffic management can be found on the following page.

Duration of works

Phase one: 29 to 30 March 2021

Phase two: 31 March to 2 April 2021

Working hours

8am to 6pm Monday to Friday, and 8am to 1pm Saturdays if required

We may be on site for an hour before the start and/or end of the shift

What to expect

You may notice some additional noise from the tools being used

A pedestrian diversion will be in place and bus stops V & N on Victoria Road will be suspended temporarily

What we will do

Remove vegetation using handheld equipment

We will monitor our work methods to ensure they are safe and reduce the impact to the local community


Carry out ecology surveys before the vegetation removal starts
