

Upcoming works at Vehicle Holding Area

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Traffic management on Prince Albert Road

Construction of the Vehicle Holding Area is ongoing in the London Zoo car park so lorries can avoid queueing at nearby worksites whilst making deliveries. We will install permanent traffic lights and a pedestrian crossing on Prince Albert Road later this year, at the entrance to the Vehicle Holding Area to manage traffic and enable lorries to safely enter and exit the holding area.

In the meantime we will use temporary traffic lights to manage traffic flow in this area. The temporary traffic lights will be in place from week starting 10 May. We will provide an update once we confirm the installation date for the permanent lights.

White lines repainted on Prince Albert Road – 5 to 6 May

On 5 and 6 May, we will mark the new traffic lights and pedestrian crossing on Prince Albert Road with white lining. The works will take two days and involve alternating lane and footway closures, temporary traffic management and pedestrian diversions.

We will always ensure we maintain access to properties.

Installation of site services – April and May

We are now nearing the completion of the Vehicle Holding Area. Over April and May we will carry out works to complete the internal fit-out of the Vehicle Holding Area, including the installation of site services. This includes lighting columns for site safety and security. Please be assured, the brightness of these lights will be lowered each night from 7pm to 7am to reduce the impact on residents. However, we cannot turn the lights off altogether.

Vehicle Holding Area operational from May

The Vehicle Holding Area will be partially operational from May, gradually building up to full operational capacity by July. There will be a gradual increase in the number of lorries to and from the Vehicle Holding Area. We will always remain within the number of lorries allowed within the HS2 Environmental Statement. Operating hours will be Monday to Friday 8am – 6pm, and Saturday 8am – 1pm. We will be on site for an hour before the start and/or end of each shift for site set up and tidying up of the site at the end of the day.

From Prince Albert Road, lorries will turn left in and right out of the Vehicle Holding Area access gate with traffic signals for safety. Transport for London has assessed the location of the access point to ensure it is a suitable distance from the Prince Albert Road/Parkway junction to manage traffic flows in the area.
