Update: Notice of utility surveys at Cedar Avenue and Great Central Avenue

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

We wrote to you previously to advise you that we would be carrying out utility surveys from 15 to 17 March. However, we will now require additional time to complete these works. The extended period will be from 6 to 16 April 2021.

We will be carrying out ground and sewer system investigation at Cedar Avenue and Great Central Avenue, in the area shown on the map overleaf.

The ground investigation will involve the use of scanning equipment to identify the utilities in the area. We will be excavating trial holes to take measurements and ground samples.

To investigate the condition of the sewer system and the manholes, we will be using a CCTV camera mounted on a small robot. Should we find a blockage we may need to flush the drainage system using a high-pressure water jet in order to carry out the investigation.

How the surveys might affect you

Due to the location of the utility surveys below the road, temporary traffic management will be in place. This is to ensure that the surveys can be carried out safely.

There will be no disruption to your utility services.

Duration of works

The activity will take place from 6 April to 16 April 2021

The hours of work will be 8am to 6pm Monday to Friday and 8am to 1pm on Saturdays

We may be on site for an hour before the start and/or end of each shift

What to expect

Traffic management, operatives, excavation equipment to take samples and measurements, and surveying equipment, including a CCTV camera

What we will do

Use of water carts to keep dust to a minimum

Your utility services will not be affected


Maintain access to your property at all times
