High Speed Two (HS2) is the new high speed railway for Britain.

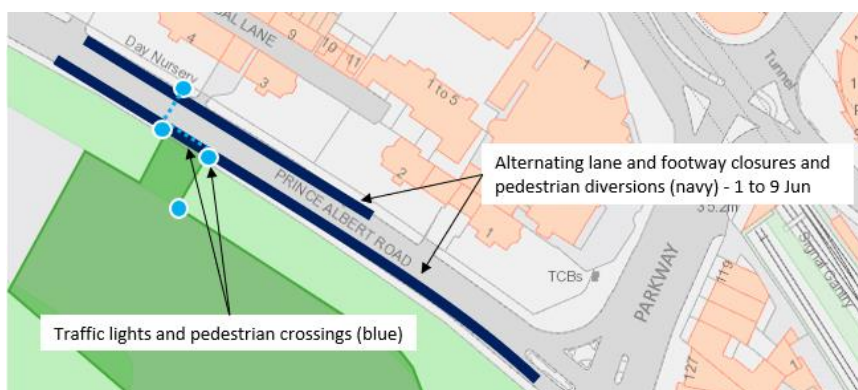
We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Permanent traffic lights installation at the entrance to Vehicle Holding Area – 1 to 9 June

We previously informed you we will be installing permanent traffic lights and a pedestrian crossing at the entrance to the Vehicle Holding Area on Prince Albert Road, to enable lorries to safely enter and exit the site.

Transport for London has now confirmed they will install the traffic lights and pedestrian crossings from 1 to 9 June, to coincide with the school half-term holiday.

We will have alternating lane and footway closures in place, as well as pedestrian diversions, for safe working. Access to properties will be maintained at all times.



We will begin using the Vehicle Holding Area from June, building up to full capacity by August. For further information please see the original notice, 'Upcoming works at Vehicle Holding Area'.
