High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. CCTV utility surveys in Stanhope Street and Augustus Street - 11 May

We previously informed you CCTV surveys of utilities on Stanhope Street and Augustus Street would commence on 5 to 6 April, however due to unforeseen circumstances we were unable to carry out the works. The surveys will now take place on Tuesday 11 May. Traffic management including temporary lane closures and parking bay suspensions on Stanhope Street and Augustus Street is required to safely carry out the works. Footpath closure on Harrington Street next to Coniston extended until 31 May

Hoarding realignment and works to install new water pipes are in progress at Harrington Street next to Coniston, however due to coordination with other works in this location the works will now take a further three weeks and will be completed on 31 May.
