

# Notice of road closure, Culworth Road

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance.

Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ## What will be doing?

In preparation of our main works starting, we will be carrying out reptile habitat assessments which forms part of our reptile translocation works. The surveys will be completed by ecologists who evaluate the local habitat potential to support reptiles. We will be undertaking a walkover survey that will take place along Culworth Road between 9:30 am and 3:30pm Monday 12 April 2021.

There will be a diversion in place during this period and the road will be open as usual outside of these times.

## What will we be doing? (continued)

To notify road users of the upcoming road closure, verge advance warning signs will be erected.

The diversion signage will be in place and operated during the working hours described on Monday 12 April 2021. These signs will be mounted on standard A frames and secured with ballasted sandbags.
