

Works next to Langdale footpath - March

High Speed Two (HS2) is the new high speed railway for Britain.

We are following Government and Public Health England (PHE) advice on working safely during the pandemic. As we increase face to face engagement, in addition to virtual engagement, we will ensure all events and meetings adhere to the guidelines. Footway closure for works next to Langdale footpath – from 14 March to 1 April

We previously informed you, we will install a permanent fence around the substations next to Langdale footpath. We now plan to start these works on 14 March.

We will remove the temporary barriers and cut down the existing section of fence, before replacing it with a 2.4m green wire fence and gate. It will take us about an hour to cut through the existing fence, we will use acoustic blankets where possible to limit noise from these works.

We will close the Langdale footpath between Stanhope Street and Harrington Street to create a safe working area. We will also close a section of the footway on Stanhope Street, beside Langdale footpath. Pedestrians will be diverted via Mackworth Street while the footpath between Stanhope Street and Harrington Street is closed.

These works will take about a week to complete.

We will then work within the newly fenced area to install cables between the substations and our worksite. We will break out the ground and install a concrete slab, before fixing the cables to the slab. There may be periods of increased noise from concrete breaking or drilling and we will use acoustic blankets to reduce noise where possible. We expect this work to take about two weeks to complete.
