High Speed Two (HS2) is the new high speed railway for Britain.

## Update: utility works on Hampstead Road – November to spring 2022

We recently informed you we will install traffic management on Hampstead Road for utility works.

We have already closed a section of the western footway and one of the northbound lanes on Hampstead Road, between Varndell Street and Mornington Crescent to make way for our works onsite.

In late-November we will temporarily close a section of the footway on Hampstead Road, just south of Mornington Crescent to make way for utility works. We will install an alternative pedestrian route to maintain pedestrian access in this area. This footway closure will remain in place until the utility works are complete in spring 2022.

## Update: new site access on Hampstead Road – late November to late January 2022

We previously informed you, we will install a second site access on Hampstead Road to maintain access to and from the main road while the current gate is closed for utility works.

From 22 November we will carry out works within the existing traffic management on Hampstead Road to remove the site hoarding and install new access gates. We will use this new site access (Access 2) from late-November to late-January, while the current access (Access 1) is closed.

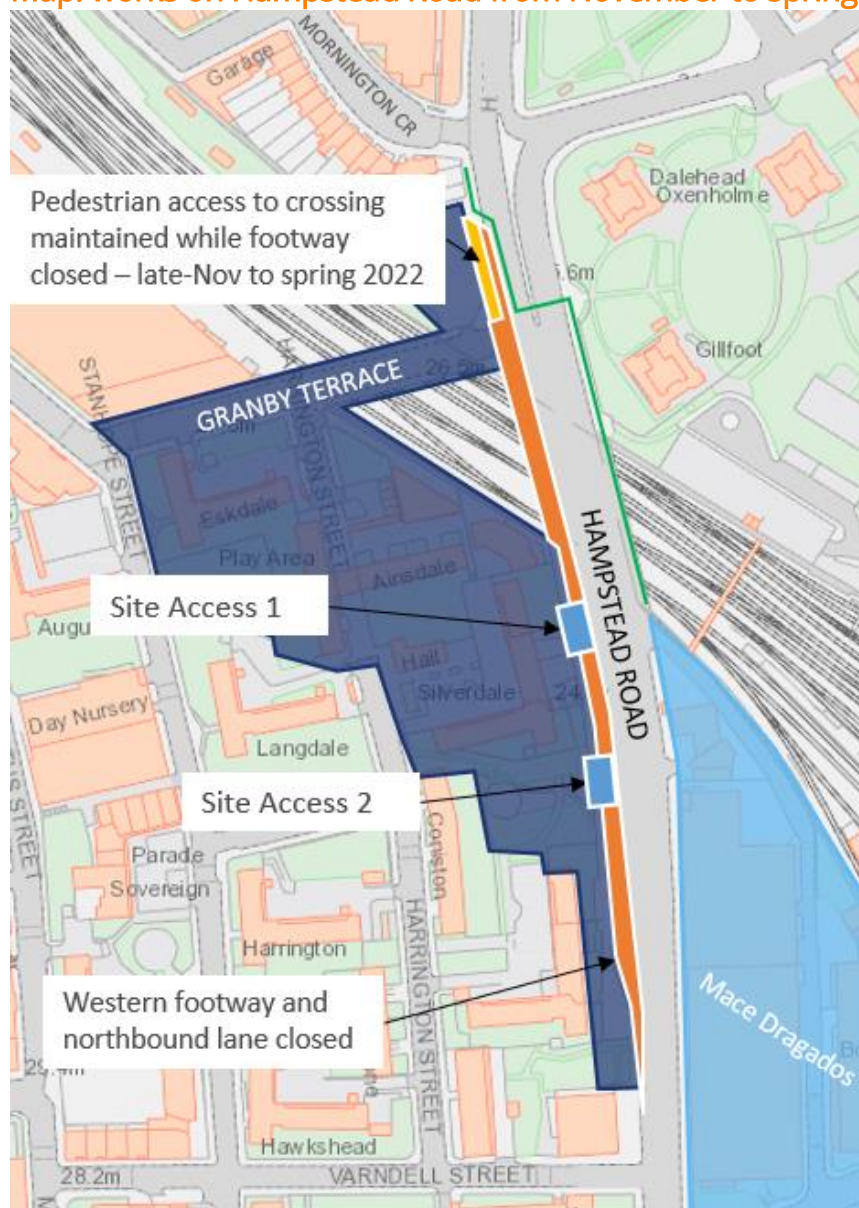

## Trial hole surveys on Hampstead Road – from 6 December

In December we will carry out two trial hole surveys on Hampstead Road, in front of site access 1, within our existing traffic management. We will assess the ground and structure of the bridge in this area. This survey will be used to inform the design of the Hampstead Road bridge extension.

## Overnight surveys on Hampstead Road and Euston Road – 2 December

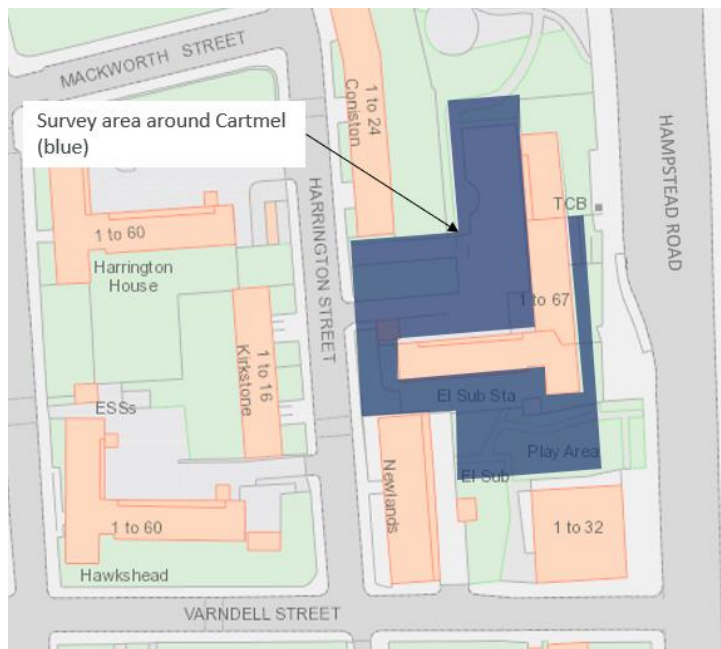
On Thursday 2 December we will carry out surveys within the footway on Hampstead Road and Euston Road. A team of three surveyors will work overnight from 9pm to 5am, using tripods and handheld equipment (like the one pictured). We will carry out the surveys at night when there is less traffic and pedestrians, so we have a clear line of sight between survey points.

These surveys will not be noisy, and we do not expect residents to notice.



## GPR surveys around Cartmel – 13 to 17 December

On week starting 13 December we will carry out ground penetrating radar (GPR) surveys in the area around Cartmel building, outside our worksite. A team of surveyors will use a small, wheeled machine to assess for underground structures and utility services in the area marked on the map below. These surveys will not be noisy, and we will carry them out during core hours over two or three days .
