# Update: works on Prince Albert Road


High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at HS2.org.uk.

## Update: works on Prince Albert Road- 6 to 10 September

We previously informed you of our plans to remove the old road markings on Prince Albert Road, and adjust the final position of the traffic lights in front of the Vehicle Holding Area. We will now carry out these works from 6 to 10 September.

Please be aware there may be periods of increased noise, while we break out the footway to adjust the lights or use water blasting to remove the old white lines from the road. We will require lane and footway closures and a pedestrian diversion on Prince Albert Road to safely carry out these works.
