High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England advice dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Only sites operating within the guidelines are operational. All sites remain under constant review. We have postponed all face-to-face engagement and have put in place various channels to communicate with communities, such as letters, phone calls, local community websites updates. What will we be doing?

We wrote to you in December 2020 to advise you of our continuing works ahead of the construction of the railway in your area in relation to archaeology and the construction of a bat house. The archaeological works are now complete and construction of the bat house is now underway. As part of the bat mitigation licenced work we also need to need to undertake the removal of roof tiles from adjacent Park Hill buildings that are within HS2 land possession, ahead of later demolition.

Trackway matting and site welfare

To undertake the work at Park Hill we have laid temporary trackway matting. This provides direct vehicle access to the A413 at the Link Road, Great Missenden. We have also established a small welfare set up. Please see enclosed map. For the roof tile removal works at Park Hill we will use the same existing welfare arrangements.

Duration of works

Works will continue until spring 2021

Normal working hours:

Monday to Friday 8am -6pm

Saturday 8am - 1pm Saturday extended works beyond 1pm until 6pm (subject to consent)

Our contractors will be on site for one hour's start-up and shut down either side of these times.

What to expect

Slight additional traffic on local roads.

Noise from the equipment used for the works.

Site storage and welfare vehicle operated with 24hr security and low level lighting.

Traffic management signage near our site entrance.

What we will do

Manage any impacts, such as traffic and noise with the aim of reducing or removing them.

Bat house construction

Our ecology surveys identified that local HS2 owned properties are used by bats as a roost site. As we need to demolish these buildings ahead of the construction of the railway, a new bat house is being built to accommodate these bats.

This new bat house design has been approved by the local authority and considers the subsequent requirements of the bat licence. A further community notice will be issued ahead of the demolition works.

The construction of the bat house comprises of the following:

- Single storey pitched tiled roof building
- Approximately 10m height x 10m length x 10m width
- Brick construction, clad with timber sympathetic to the local architecture
- The building is designed to mitigate for the bat species surveyed in the area containing a variety of roost types for the bats to choose from
- Construction and completion of the building by spring 2021

The bat house is being constructed within a pre identified and segregated area within the Park Hill habitat mitigation site. Access to the work site is via the HS2 internal access road directly from the A413.

Bat mitigation

Part of the work at Park Hill involves removal of the roof tiles from the buildings. The works will be supervised by an ecologist who will be present on site and provide the appropriate approvals for all protected species prior to the works commencement. Works will be undertaken in accordance with the approved licence methodology.

Bat house working hours

To complete the bat house construction we may need to work extended Saturday working hours on the 10, 17 and 24 April beyond 1pm. The extension until 6pm is subject to consent approval from the local authority. There may be some intermittent ambient noise from the bricklaying and bat house construction activity with a small number of work force on site. No other construction activity will be undertaken during the period and no lighting is required for these works.
