High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

Work will we be completing

From **19 April 2021** we will be implementing a three-way temporary traffic light system on Watton Lane and Gypsy Lane to enable trial holes and vegetation clearance works on Watton Lane. The trial holes will help us identify any utilities and the vegetation clearance will enable us to create an access point to a compound area BBV will construct in the coming months.

The temporary traffic lights will be in place 09:30 - 15:30, Monday – Wednesday. There will be a single lane closure to divert the public footpath from the working area. Once the work is finished, the traffic lights will be taken down. There may be other times we need to implement traffic management onto B4117 Watton Lane. If this is the case, we will update you through HS2 Warwickshire community website.

COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. - Subject to consent temporary traffic lights will be in place from 19 April for 3 days
- Our working hours will be Mon – Wed from 9:30am – 3:30pm

- Slight increase to traffic on B4117 Watton Lane
- Slight increase in noise levels
- Our workforce to be on site 1 hour before and 1 hour after, to set up and take down equipment

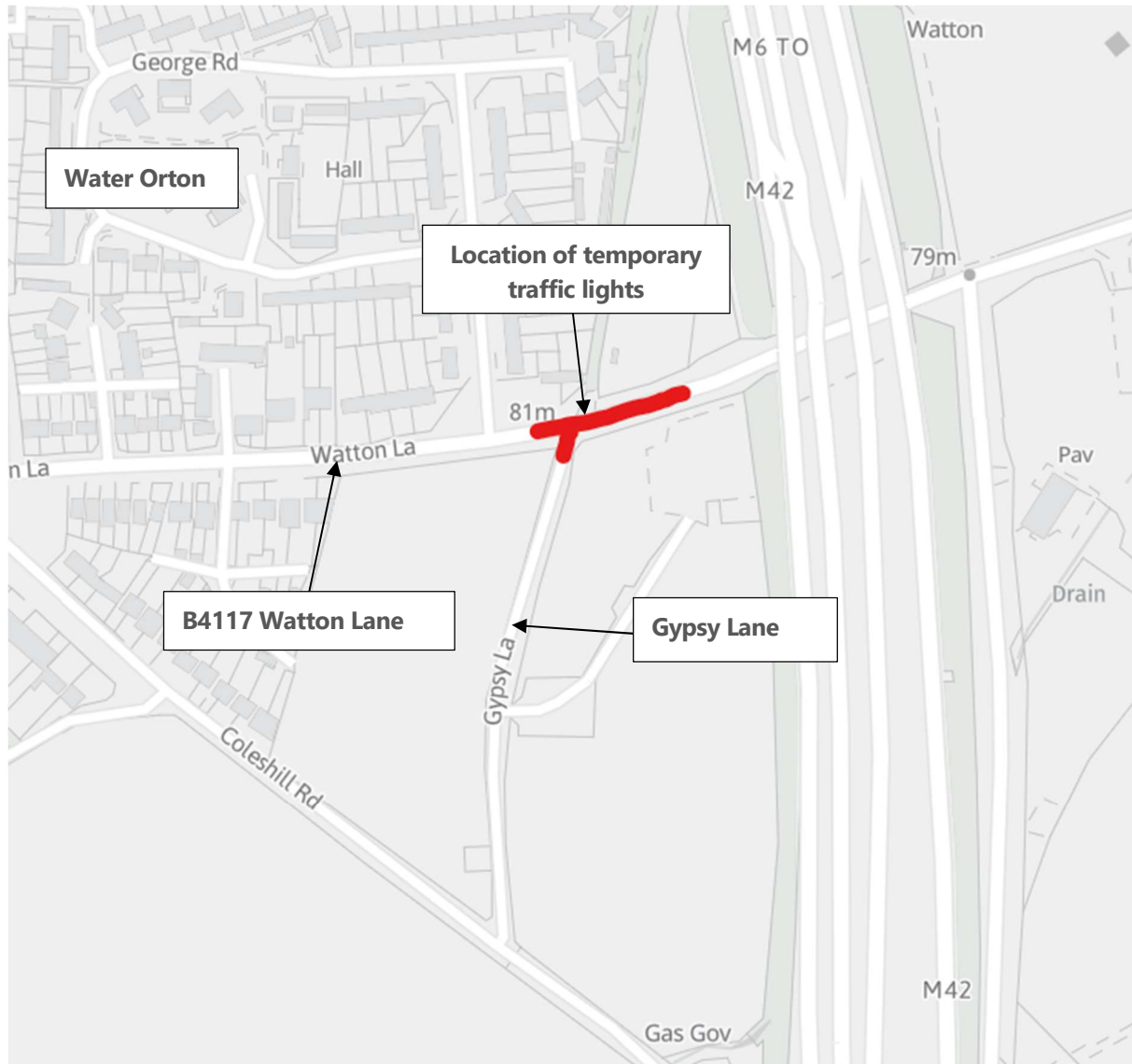
