Update: conveyor colour within the sites in Old Oak and Park Royal

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

Installation of conveyor during 2021

During 2021, our contractors SCSJV and BBVS will build a conveyor system between our sites in Old Oak and Park Royal to allow for the movement of excavated material between sites. This will assist with reducing construction traffic on local roads while we build HS2.

What the conveyor will look like

We are planning to install a light grey conveyor which blends in with the local surroundings.

On the sections of conveyor located within our Crossover Box, Flat Iron, Atlas Road and Willesden Euroterminal sites, we will install light grey noise barriers. The noise barriers will be solid so you will not be able to see through them from your home. You can view images on the following page showing what the conveyor may look like in these sites.

The section of conveyor from the Old Oak Common Station site to the Flat Iron site is also planned to be light grey.

As you may be aware, some sections of the conveyor will cross local roads, the railway and Grand Union Canal. We are considering how the conveyor will appear in these locations and will engage further with local resident groups about this. We will provide more information about the appearance of these sections of the conveyor.

What the conveyor may look like

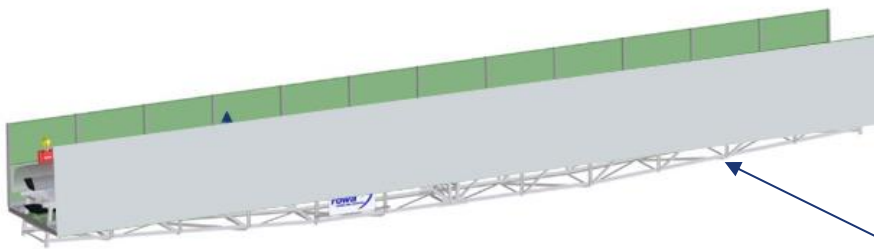

The final conveyor design is still being confirmed. We hope to provide more information to residents about the conveyor design during spring 2021.

In the meantime, the images below show what the conveyor may look like in the Crossover Box, Flat Iron and Atlas Road sites, where we will install solid, light grey noise reducing barriers on the conveyor system.

Image 1 – section of conveyor in Crossover Box and Flat Iron sites

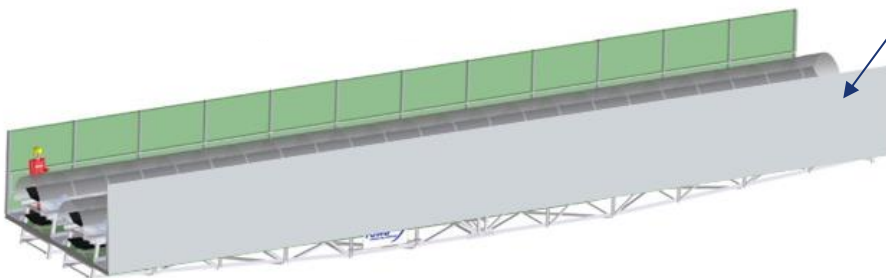
The image below shows an example of what the light grey noise barriers may look like in our Crossover Box and Flat Iron sites.

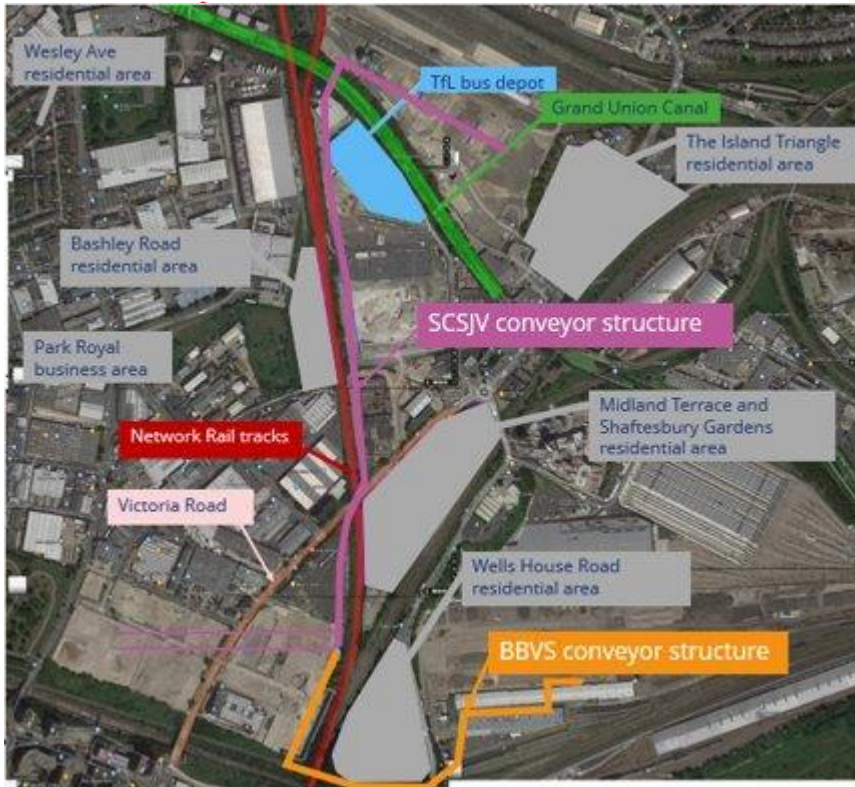
