## **Notice of temporary road closure Lichfield Road, Whittington area**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

Due to a change in our schedule, these works have new dates.

#### The work we are doing

We will be carrying out trial trenching, along a section of Lichfield Road, which will involve digging into the ground to establish what is underneath the surface. This will provide us with information on the location of underground utilities, which we need to assess as we develop our construction plans.

For the work to be completed in a safe environment, we will be temporary closing Lichfield Road.

There will be access to the frontages.

#### When will we undertake these works

The temporary road closures will be in place from 26 April to 29 April between 9:00am and 3:30pm. Our teams may be on site up to one hour before and one hour after the works to set up and secure the site at the end of each day.

#### **HS2** and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry auidelines.

Keep all sites safe and secure.


