# **Update: Notice of ground surveys at Stonefield Park**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

#### What we are doing

We wrote to you previously to advise you that we would be carrying out utility surveys from 29 March to 1 April. However, we have rearranged these dates and the surveys will now take place from 7 to 9 April.

We will be carrying out ground investigations at Stonefield Park, in the area shown on the map overleaf. This will help to inform our design decisions in the area.

The ground investigation will use scanning equipment to identify existing utilities in the area.

We will be excavating trial holes to take measurements and ground samples.

#### How the surveys might affect you

We will cordon off the working area, maintaining a public walking route at all times.

There will be no disruption to your utility services.
