# Update: traffic impacts on Stanhope Street and Park Village East

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. # Stanhope Street road closure for main site cabin deliveries – extended until 12 June

We are currently installing a five-storey site office within our worksite on the corner of Stanhope Street and Granby Terrace, next to Langdale.

We have lorries delivering pre-built cabins to our worksite via Park Village East. These lorries park on Stanhope Street, where we then use a crane to lift the cabins from the lorry into place onsite.

We previously informed you we need to close a section of Stanhope Street between Park Village East / Augustus Street and Mackworth Street, to provide a safe working area. This section of road is currently closed from 9am to 3pm on weekdays and 7am to 1pm on Saturdays.

We now need to extend this road closure until 12 June.

Traffic will be diverted via Varndell Street, Cumberland Market and Augustus Street. Local access will be maintained at all times.

We apologise for any inconvenience this may cause and thank you for your ongoing patience.



# Footway closure on Park Village East for onsite substation installation – extended until 16 July

We are currently installing a substation onsite, on the corner of Park Village East and Granby Terrace. In order to make way for these works we have temporarily removed a section of the hoarding and closed the footpath immediately adjacent to the works. We now need to extend this footway closure until 16 July.

Once the substation is complete, we will reinstate the hoarding and install the new hoarding graphics before reopening the footpath.
