



Update: Notice of works happening south of the Chiltern Line

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

We wrote to you previously to advise you that we would be carrying out works in the area from 22 February to 6 April. However, we will now require additional time to complete these works. The extended period will be until 14 May 2021.

We will be creating two small work compounds, the first next to Breakspear Road South and the second, due east, in the fields next to Ickenham Cricket Club grounds.

In order to redirect the overhead electricity cables in the area of HS2 works we will, in association with Instalcom Ltd (working on behalf of SSEN), be creating the first compound, and from there we will launch a small tunnel boring machine that will drill underground due east. It will travel underneath the River Pinn and then rise into compound two. The machine will then return along the tunnel that has been created, this time drawing electricity cables back to compound one. Instalcom Ltd will then connect the services at both ends.

This will allow for all the works to be carried out in our main compound to be carried out safely with no risk to the electricity supply in the area.

To prevent closure of the footpaths, on the occasions that fencing or other materials need to be driven into the area, there will be operatives walking in front of our vehicle to ensure safety.

Until 14 May 2021

Our permitted hours of work will be from 8am to 6pm Monday to Friday and 8am to 1pm on Saturday should this be required

What to expect

The areas of works will be surrounded by metal wire fencing and will be clearly marked

Operatives carrying hand tools will be seen in the area

The small tunnel boring machine makes very little noise or vibration

What we will do

We are working with Instalcom Ltd to ensure all work is carried out safely and to ensure that there is no interference with supply.
