## Notice of CCTV surveys at Mandeville Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

#### What we are doing

We wrote to you previously to advise you that we would be carrying out utility works from 10 to 11 April and 17 to 18 April 2021. However, we have rearranged these dates and the works will now take place on 7 and 8 May 2021.

We will be carrying out night-time utility surveys under the railway lines at Mandeville Road, shown on the map overleaf. These surveys will provide us with information on the condition and location of the utility services and help us to decide how best to protect them while we are building HS2.

We will investigate the condition of the sewer system using a CCTV camera mounted on a small robot. Should we find a blockage, we may need to flush the drainage system using a high-pressure water jet in order to carry out the investigation.



#### How the surveys might affect you

The surveys will be carried out at track level, during a planned night time closure of the lines. To ensure the surveys can be carried out safely, temporary traffic management and a lane closure will be required.

During this period of work bus stop B, towards Greenford, Southall or Hayes, will be out of service. The nearest bus stop will be south on Mandeville Road at bus stop D, Moat Farm Road.
