Notice of works at Breakspear Road South

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

The road crossing at Breakspear Road South will become operational for our site traffic from 10 May 2021. The London Borough of Hillingdon has approved a speed limit reduction from 40mph to 30mph between Swakeleys Road and Breakspear Road, and to 20mph near the haul road crossing.

To ensure that this area is ready, we will be carrying out road and utility works along Breakspear Road South from 7 May 2021, in the area shown on the map overleaf.

These works will include the installation of concrete traffic barriers and line markings. Additionally, we will investigate the condition of the culvert system using a CCTV camera mounted on a small robot.

Your utility services will not be affected.

Most of the work activities on the carriageways will be restricted to lane closures. However, for safety reasons there will be a full road closure needed for one night on 7 May.

Duration of works

Overnight road closure on 7 May 2021 between 9pm and 5am

Lane closure on 8 and 9 May between 9am and 5pm

We may be on site for an hour before the start and/or end of each shift

What to expect

Traffic management, operatives, and surveying equipment (including a CCTV camera)

Temporary traffic signals supported by operatives during the busiest parts of the day

What we will do

Maintain access to your property at all times


