Hoarding graphics install on Park Village East

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Hoarding graphics install – 10 to 21 May

We will install graphics on the hoarding along Park Village East, south of Mornington Street bridge, from 10 to 21 May. Local residents said they would like the graphics to reflect the character of the local area, to mitigate the visual impact of the hoarding. We have therefore designed graphics with a photographic replica of the existing wall and shrubbery along northern Park Village East. We have temporarily removed a section of the Park Village East hoarding beside Granby Terrace and will install graphics on this section once it is replaced later in May.

The works require the temporary closure of the eastern footpath immediately adjacent to the hoarding.



We require the hoarding in this location for the duration of main works in Euston Approaches. HS2 may also need this hoarding for future contractors, and HS2 will update the community when more detail is available at the end of main works.
