

Notice of archaeological excavation works – Lower Boddington

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What will we be doing?

As part of HS2's continued programme of archaeological works in your local area we previously carried out non-intrusive geophysical surveys and trial I trenching to identify areas of possible archaeological interest. Following on from the results of these surveys we will now go onto the next steps of our archaeological investigation work, this will involve further excavation and recording any finds.

The mitigation investigation works will involve stripping of the topsoil and recording any finds. The digging and investigations are carried out by our archaeology subcontractor with supervision staff visiting the site to ensure the works are progressing safely. Once the work is complete, the area will be backfilled.

We will begin archaeological investigations in the Lower Boddington area starting in late May 2021 and will be completed by the end of July 2021. Refer to the map enclosed of the work area.

Duration of works

The works will start late May 2021 until the end of July 2021.

Normal working hours:

Monday to Friday 8am – 6pm.

Our contractors may also be on site for one hour's quite start-up and shutdown outside of these times.

What to expect

Some additional traffic on local roads.

Noise from the equipment used for the works.

Site operated with 24hr security and temporary lighting.

Site storage and welfare vehicle.

What we will do

Manage any impacts, such as traffic and noise with the aim of reducing or removing them.

What will we be doing continued.

To enable us to carry out the works, we will need to construct a small welfare facility and lay down area. This will involve the placement of temporary field trackway matting.

Our establishment will include:

- Additional temporary trackway
- Office and welfare facilities alongside a small storage area for machinery and materials
- Car parking for a small workforce and 24-hour security with temporary low level lighting

How may this affect you?

We will be working hard to ensure any impacts on residents are kept to a minimum during these and all our future works.

You may notice a little extra traffic on the road immediately around the sites with workers moving to and from the site, and occasional delivery vehicles.

There may be some noise from the machinery. All machinery will be restricted to running between the hours of 8am to 6pm Monday to Friday and when required 8am to 1pm on a Saturday.
