SCS site offices installation and Euston Throat works update

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Stanhope Street closure for site offices installation – 17 May to 9 June on weekdays from 9am to 3pm

From 17 May to 9 June we will install a five-storey site office (see map 1) within our worksite on the corner of Stanhope Street and Granby Terrace, next to Langdale. Lorries will deliver about 10 portacabins a day over four weeks via Park Village East during normal working hours. Please accept our apologies for the impacts these large loads could cause residents. We have the permission of the Met. Police and will always ensure local access and follow strict road and pedestrian safety measures.

We will locate a large crane within our worksite adjacent to Stanhope Street to lift the cabins from the lorries into place. To provide a safe area around the lorries, we need to close a section of Stanhope Street between Park Village East / Augustus Street and Mackworth Street. We will close the road between 9am and 3pm on weekdays during this period to reduce the impact as much as possible on school traffic. We will ensure local access at all times. Traffic will instead use Varndell Street, Cumberland Market and Augustus Street.

From June to October, we will fit out the offices with internal walls, air conditioning, fire systems, plumbing, electrics, furniture and a roof viewing gallery facing the worksite. We have permission to carry out the fit-out from 7am to 10pm to speed up completion. The works will be contained within the offices and will not be noisy. We have very limited site office space available to accommodate our team until we move into this main site office so we will begin to occupy each floor as soon as it becomes available, starting in August.

Traffic diversion via Varndell Street, Cumberland Market and Augustus Street

Evening working while we fit out our offices



Meanwhile, we also need to install additional double-storey temporary offices within our worksite next to the former Silverdale building in early May. We will remove these temporary offices once our new offices at the Granby Terrace site are fully operational.

Hoarding replacement on Stanhope Street - July

To meet the fire regulations for our hoarding next to our main site office, we need to replace the existing 3.6m high hoarding around our worksite on Stanhope Street. We will carry out the works over four weeks in July and replace the same graphics. Traffic management will include a lane and footpath closure and parking bay suspensions on Stanhope Street. We will provide an update on confirmed dates for this work nearer the time.

UKPN works on Stanhope Street - 9 to 17 June

UKPN are currently excavating trenches to install electricity cables as part of an ongoing phased work programme and will begin work on Stanhope Street in June. The works will require a lane closure and parking bay suspensions on Stanhope Street.
