High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

On 17 May and 1 June 2021, we will be carrying out ecological surveys along Newyears Green Lane, in the area shown on the map below.

A road closure is required between 8pm and 5am to ensure these works can be carried out safely.
