High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons. Please note that all of the times and dates in this notification are subject to change.

There will be weekend working near Middleton

Following our notice about traffic management on Church Lane, please be informed that LM will need to work on **Saturday 1 May**, subject to consent. This is to continue our vegetation removal works including activity to mitigate impacts on the local bat population.

This work will take place on **the above date between 8:00am and 6:00pm**. We may be on site up to one hour before and one hour after these times to set up and secure the site.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance.
