High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### **Traffic management**

To allow us to construct a new site compound access off the A429 Kenilworth Road, (between Kenilworth and Coventry and close to Milburn Grange Farm) we need to install temporary traffic lights.

The temporary traffic lights will be in place from 10 May to 28 May. During busier periods of the day these lights will be manned to aid the flow of traffic and reduce disruption.

#### **HS2** and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.
