

Central reservation removal on Hampstead Road


High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Northbound lane closed and bus stop W suspended – 17 May to 14 June

We are pleased to say, following community feedback, we now have agreement with Transport for London to create a right turn out of our Hampstead Road worksite gate. The right turn means lorries can avoid using Harrington Square as a turning loop to head south to Euston Road. To create this right turn, we will remove the central reservation Hampstead Road. Works will take place in three phases. Phase 1 is shown in map 1 below.

Duration of works

17 May to 23 August

Monday to Friday 8am to 6pm and Saturday 8am to 1pm

Night works for white lining on completion of phase 3: midnight to 5am (we will confirm dates nearer the time)

We may be on site for an hour before the start and/or end of each shift

What to expect

Bus stop W suspended

Northbound lane and footpath closures on Hampstead Road, two-way traffic moved to the southbound lanes

What we will do

Maintain two-way traffic on Hampstead Road
Minimise noise wherever possible


To carry out the works in phase 1 we will close the northbound lanes on Hampstead Road and move two-way traffic to the southbound lanes. We will temporarily suspend the southbound bus lane and bus stop W. The nearest alternative bus stops are Robert Street stop J and bus stop K near the corner of Netley Street and Mornington Crescent underground station. During phase 1 of the works, the exit from Varndell Street onto Hampstead Road will be closed and vehicles will only be able to turn into Varndell Street from Hampstead Road.

Phases 2 and 3 – 23 July to 23 August

Phases 2 and 3 as shown in map 2 below will also require northbound lane closures and a temporary suspension of bus stop W. We will reinstate the white lining on the road, which will involve night work with exact dates yet to be confirmed. We will provide more information of other potential impacts and confirm dates nearer the time. On completion of phase 3, the right-hand turn from our worksite onto Hampstead will be enabled.

The works will generate some noise and dust. We will reduce impacts with acoustic screening and have dust and noise monitoring measures in place. We apologise for any disruption and inconvenience this work may cause.
