High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

What does this mean in terms of our planned works

Operational works at Balfour Beatty Vinci's North Portal are progressing well. With deliveries now resumed of earthworks plant machinery and tunnel boring machine (TBM) segments, we intend to work 24 hours each day, as follows:

17 May 2021 – 13 July - Monday to Saturday, (no later than midnight on Saturdays) over a period of nine weeks, starting from later this month.

24 May 2021 – for up to a maximum of three weeks – 24 hours each day, 7 days a week

When will the extended working hours begin

The extension to core working hours has been granted by the relevant local authority under Section 61 of the Control of Pollution Act 1974.

From 17 May 2021 until 13 July 2021 our core working hours will be extended to enable us to carry out site preparation and assembly of the TBM. The level of likely impact of these activities is low.

COVID-19

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.
