High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Temporary office installation - May and June

The Vehicle Holding Area is now nearing completion and will be operational from late May.

In May and June, due to social distancing measures, we will install additional temporary offices in the Vehicle Holding Area to accommodate our growing team until November. We will locate this two-storey welfare office between the park-side hoarding and the existing three-storey site office as shown in the map below. It will not be visible to residents once installed.



We will deliver the temporary cabins as large loads outside peak hours with traffic marshals to assist. We will deliver the first set of cabins in the week beginning 24 May, and the second set of cabins in the week beginning 7 June. We will use a crane to lift the cabins from the lorries into position within the site.

The welfare cabins will be The Royal Parks dark green colour, with white window frames.

A crane will be brought onsite each time to install the cabins

Works are not expected to be noisy
