High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) alongside Laing O'Rourke and J. Murphy & Sons (LM) are working in partnership with HS2 Ltd to build the new high speed railway in your area.

Road closure and temporary traffic lights

To allow us to construct a new site compound off the B4115 Ashow Road, we will need to close the road. The closure will be during off-peak hours 9.30am - 3.30pm, from 24 May to 4 June 2021. This is to allow for plant and personnel to safely cross the road. Outside of these hours, automatic traffic lights will control traffic flow. These timings are subject to consents.

In addition, LM will be working in this location to prepare for future construction works, which include roadside vegetation clearance. This will take place during the road closure between 9:30am and 3:30pm in the week commencing 24 May. LM is also planning to work on Saturday 29th May between the hours of 9.30am – 12pm. We are working closely with Warwickshire County Council and the NHS to minimise impact on nearby vaccination centres and will be co-ordinating works with them.

Clearly marked diversionary routes will guide traffic around the works with minimal possible delay. This work will be completed as soon as safely possible.

We thank you for your patience as we complete this vital work.

HS2 and the COVID-19 outbreak

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

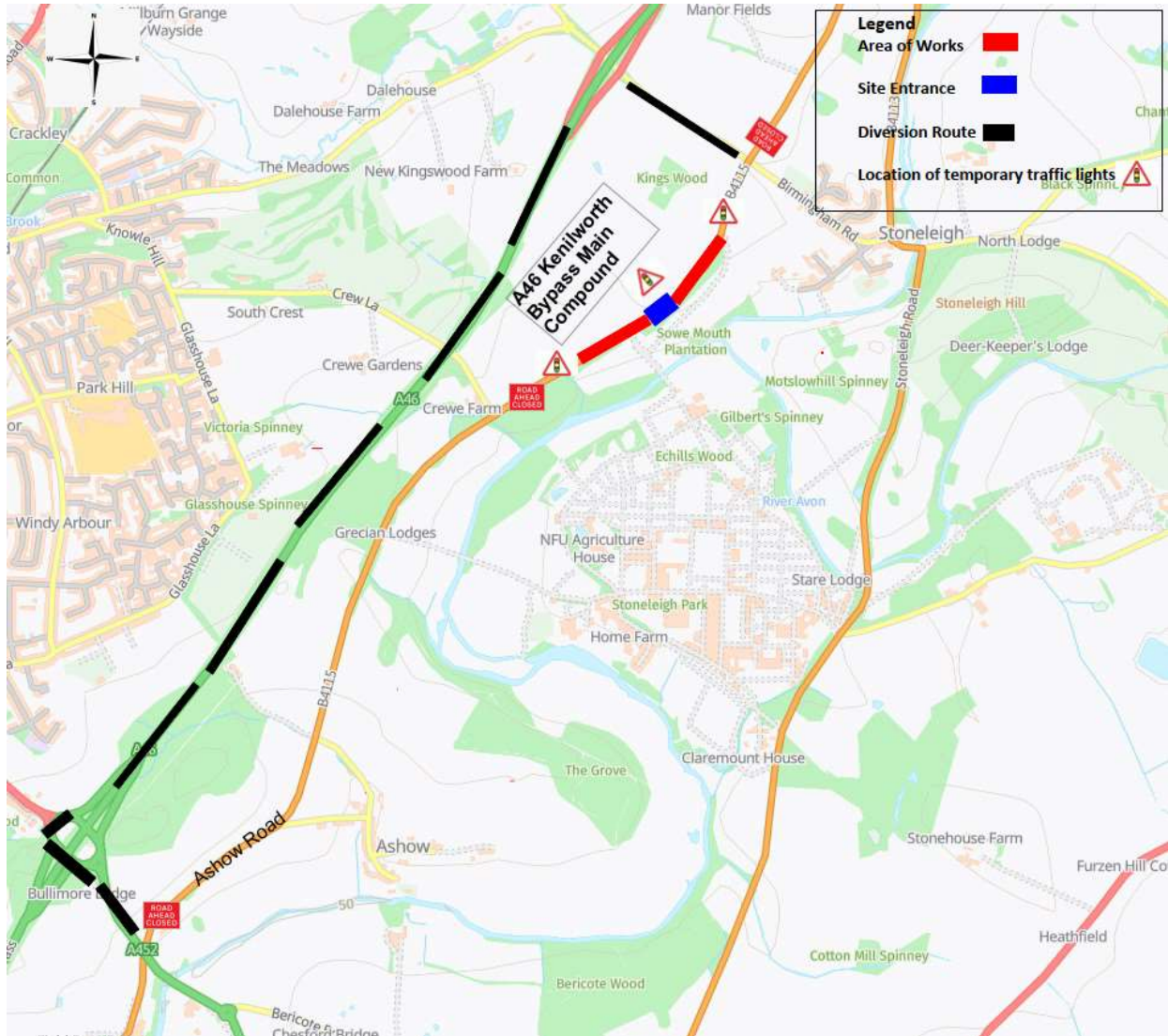
