

Notice of extended working hours at Victoria Road Crossover Box site on 12 May 2021

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

Extended working hours within the Victoria Road Crossover Box site

We previously notified you regarding ongoing and upcoming works within the Victoria Road Crossover Box site. Some of these works included the excavation of a ventilation shaft. We have completed the installation of seven concrete ring segments within the shaft and are now reaching the stage where we begin our sprayed concrete lining (SCL) section.

In order to ensure the SCL cures correctly when applied, we will need to do a test spray and concrete analysis test on a section of the shaft. Due to the curing time of the concrete the test analysis needs to commence approximately 12 hours after the concrete is sprayed. We have completed the initial test spray on 12 May before 10am. We will then carry out a test analysis on the concrete at around 10pm which will last for approximately 15 minutes. During this time, you may notice additional noise from site. We will also be using targeted lighting on site to ensure the safety of the teams carrying out the test.

There will be further extended working hours during our works at this site. We will provide further updates in the near future.
