



Notice of lane closures, Frith Hill, Gt Missenden - May

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What work will be taking place?

We are installing signs to direct our Heavy Goods Vehicles (HGVs) to our intervention shaft site off the B485 Chesham Road from the A413. To do these works safely we will need to close one of the southbound lanes at both the Link Road and Frith Hill roundabouts at Gt Missenden on Monday 17 and Tuesday 18 May between 9.30am and 3.30pm.

The shaft off Chesham Road is an intervention shaft. It will only be used by the emergency services to access the tunnel. It will not be used for ventilation of the Chiltern Tunnel.

Why do you need these signs?

As the main construction works to build the intervention shaft for the Chiltern Tunnel off the Chesham Road progress, we need to ensure our HGVs use the correct and agreed routes to get to the site. These signs are being installed at key junctions on the main road network.
