Update: Notice of night works at Long Drive

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

We wrote to you previously to advise you that we would be carrying out sewer investigation works from 6 to 11 May 2021. However, we will require two additional dates to complete these works, which will now take place on 25 and 26 May 2021.

We will be carrying out sewer system investigations along Long Drive and Victoria Road, in the area shown on the map overleaf. This will help to inform our design decisions in the area.

We will investigate the condition of the sewer system using a CCTV camera mounted on a small robot. Should we find a blockage we may need to flush the drainage system using a high-pressure water jet to carry out the investigation.

How the surveys might affect you

Temporary traffic management will be in place to ensure the surveys can be carried out safely.

Your utility services will not be affected.

Temporary traffic management, operatives and surveying equipment (including a CCTV camera)

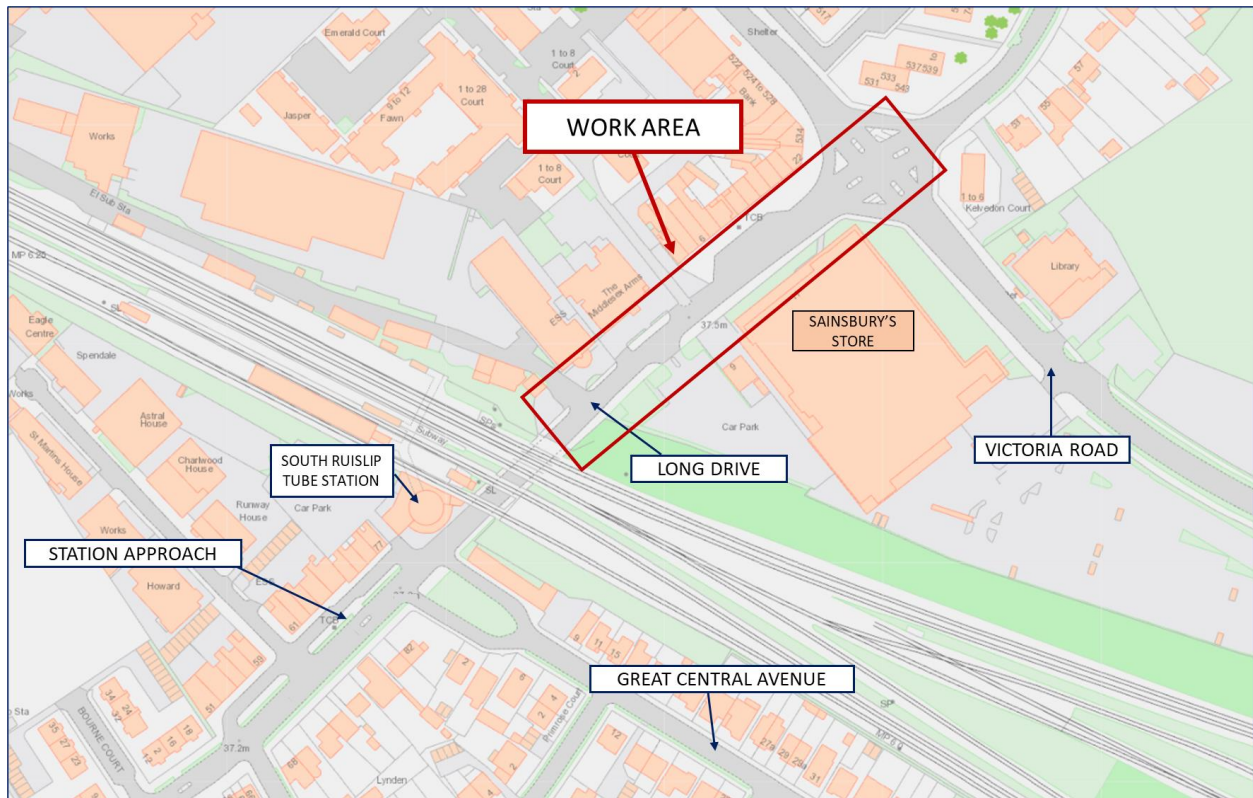
