The work we will be doing

Subject to consents being accepted we will be undertaking survey works near the M42 junction 7a northbound and southbound carriageways.

When these works will take place

The works will take place overnight on Tuesday 1 June and Wednesday 2 June. The survey works will take place from 9pm - 5am. To carry out our works safely we will:

- Implement temporary lane closure on lane 3 and 4 northbound on 1
 June
- Implement temporary closure of lane 4 southbound on 1 June
- Implement temporary lane closure on lane 1 southbound on 2 June
