High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Upcoming drainage inspections Northumberland Street

On Monday 7th June we will be carrying out a series of drainage inspections along Northumberland Street.

Drainage inspections are non-intrusive surveys. An operative will lift the manhole cover and use a sewer camera to examine the underground pipes. These surveys will help us to plan where utility diversions will be required as we prepare to construct the railway in Birmingham.

Road closure on Northumberland Street

To enable us to carry out the inspections safely and effectively, we will need to put in place a temporary road closure on Northumberland Street. The closure will be in place from 9.30am – 12.30pm on Monday 7th June.

During the closure period we will put in place a clearly marked diversion route to ensure that traffic can continue to move around the local area. The enclosed map highlights the diversion route and the road closure location. Access to properties will be maintained.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with guidance. 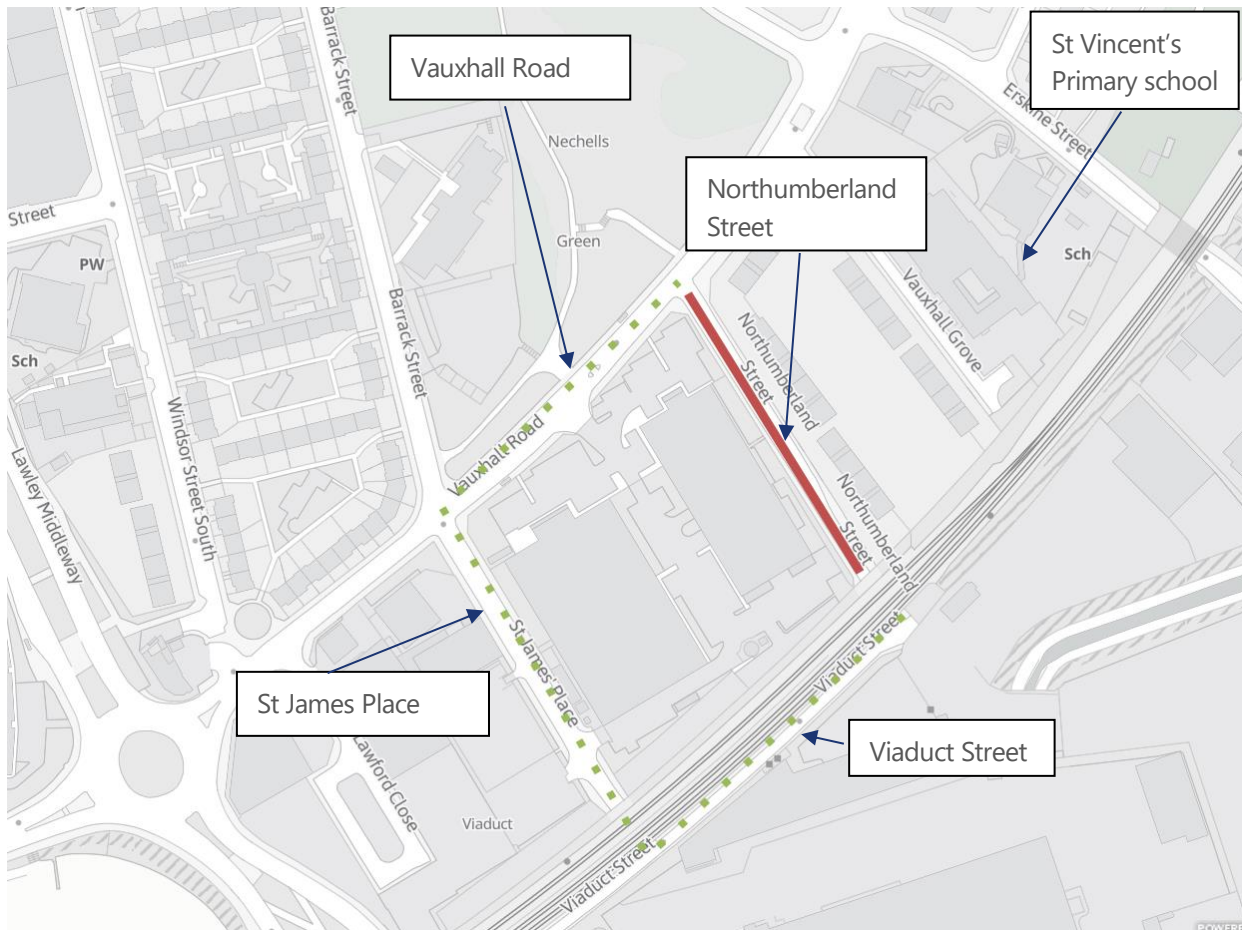
