# **Notice of works on North Gower Street and Drummond Street**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review. You can sign up for regular updates in your local area at www.HS2inCamden.co.uk.

From 24 May until 6 August 2021 utilities works for electrical power connections will take place in the road of Drummond Street and North Gower Street. Excavation and ducting work will be carried out in phases, please see the phasing below and a map on the next page;

Phase 1: 24 May to 5 June 2021 (2 Weeks)

Phase 2: 7 June to 12 June 2021 (1 Week)

Phase 3: 14 June to 26 June 2021 (2 Weeks)

Duct cleaning and CCTV: 28 June to 3 July 2021 (1 Week) - Ensuring and proving that ducts are clear of obstacles, ready for cables to be pulled through at a later date.

Reinstatement: 18 July to 6 August (3 Weeks)

At each location of works parking and loading bays will be suspended. Pedestrian access will be maintained. During the works, traffic coming from Hampstead Road onto the west of Drummond Street will be able to turn right onto North Gower Street and cross on to the east side of Drummond Street.

The initial digging of the road will be the noisiest activity, although this will be intermittent and not continuous. We will put up screening clad with acoustic panels to reduce noise.

We might use a vacuum excavator, which is a safer and faster way of working, as it sucks up material to expose buried utility services without risk of damaging the cables or pipework below. This is a noisier method, and we erect acoustic barriers around the machine, however a lot of the noise would be sent vertically, when the machine is running. We apologise in advance for inconvenience this might cause.

Utility supplies and other services will not be affected by these works.


What to expect:
