High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. Closure of part of Rickmansworth Lane and Roberts Lane, Chalfont St Peter

To safely carry out engineering surveys we will need to **close Rickmansworth Lane between Tate Road and Roberts Lane and Roberts Lane** itself from 9pm on the evening of Thursday 3 June 2021 and overnight to 5am the following morning on Friday 4 June 2021. Access will be maintained for residents and emergency services at all times.

Any Public Rights of Way will be maintained wherever possible, however whilst works are taking place access will be managed by on site staff with signage and traffic marshalling for pedestrians.

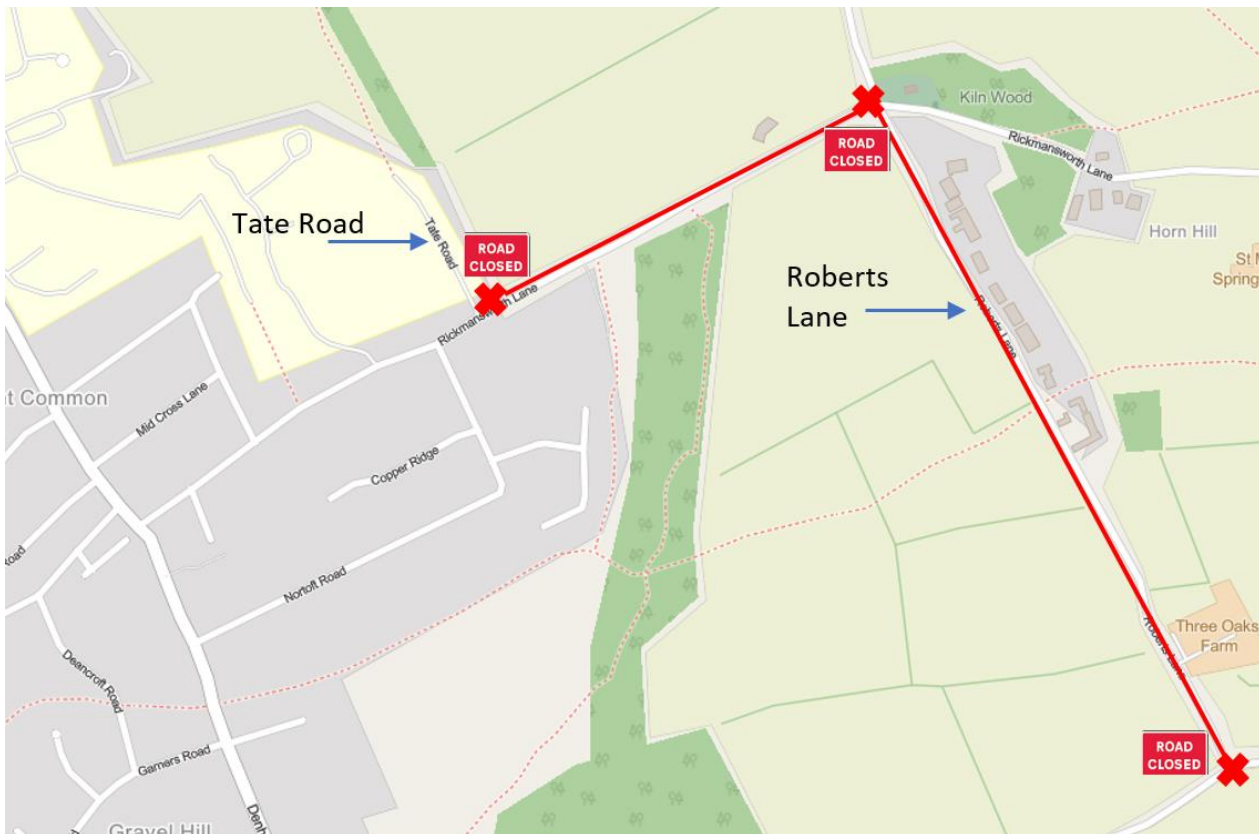

The diversion route for vehicles wanting to travel between Maple Cross and Chalfont St Peter is via the A412, A40 and A413.
