Notification



High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

From 9 to 18 June 2021, we will be digging trial holes in Victoria Retail Park on Victoria Road, Ruislip, in the area shown on the map overleaf. These trial holes will provide us with information on the condition of the ground in advance of utilities installation into our site while building HS2.

We will be digging five trial holes between Victoria Road and our site behind the Victoria Retail Park. Each trial hole will take approximately two to three days to complete.

How the work might affect you

Temporary traffic management and a lane closure will be in place to ensure the work can be carried out safely.

The Old Dairy and Victoria Retail Park will remain open during these works.

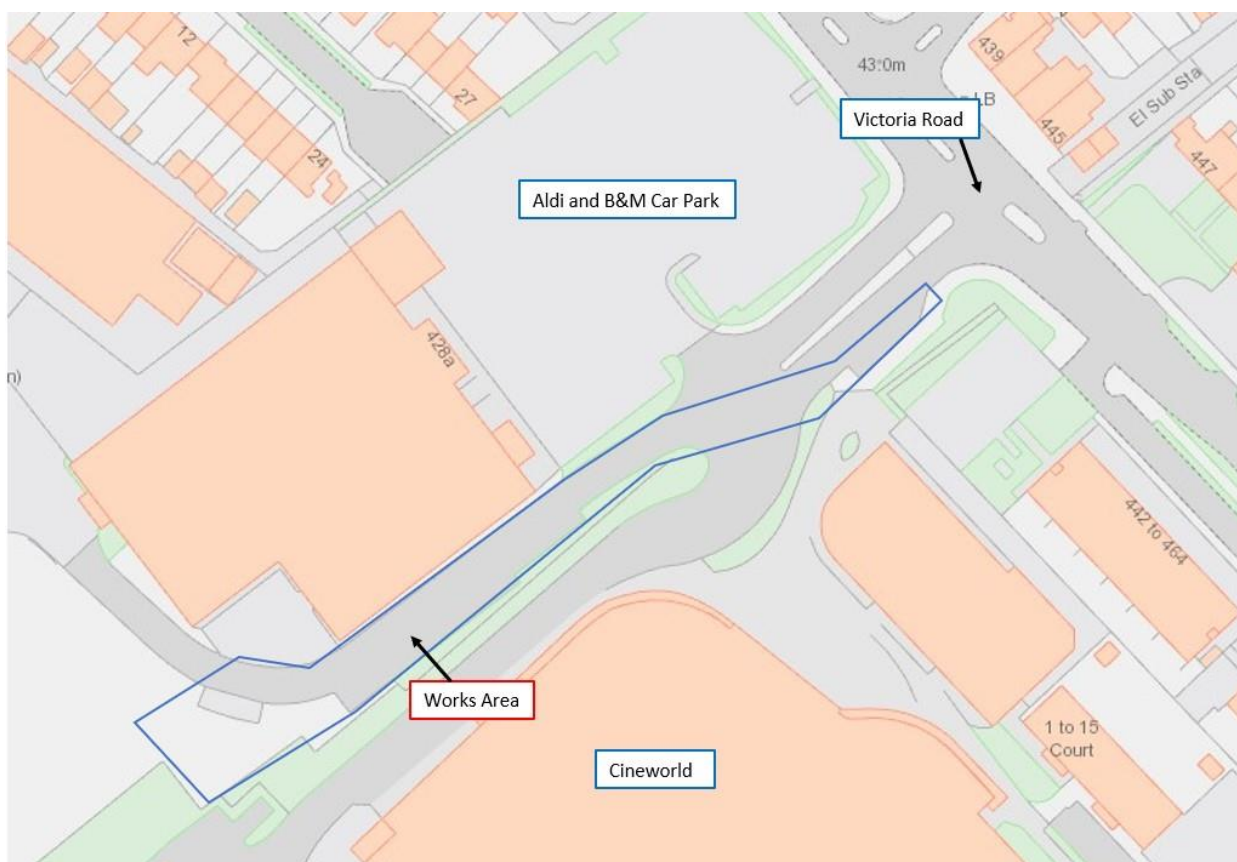
