

Update Notice: Work on Old Oak Common Lane

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

To help build the new HS2 Old Oak Common railway station, an existing sewer and utility supplies need to be moved. Parts of these services will be diverted through a section of Wormwood Scrubs. Details about the planned works on Wormwood Scrubs including previous notification letters and frequently asked questions can be found on our website <https://hs2inoldoak.commonplace.is/proposals/wormwood-scrubs>.

We are continuing to create the new access routes to the two worksites on Wormwood Scrubs off Old Oak Common Lane. We will be digging small trenches in the eastern footpath along Old Oak Common Lane to help us identify and investigate the location of underground utility cables. We will use hand held tools including breakers and circular saws, and noise reducing barriers will screen the work to help reduce noise. The footpath will be returned to normal when the work is complete.

We previously notified you that this work would take place weekend of 22 – 23 May. Unfortunately, this work was delayed, and will now take place on the weekend of 29 – 30 May. The works will require a single lane and footway closure in the area shown on the map on the following page. Temporary traffic lights will be in place to allow traffic to continue in both directions, and pedestrians will be diverted to the western footway during the works. The works are being undertaken on Saturdays and Sundays to avoid peak traffic on Old Oak Common Lane, and to prevent disrupting local businesses.
